




BRAZIL - 1930 ? - POSTCARD - A FAMILY WITH THEIR BICYCLES

Some Notes on the Post Office and Transport

When researching Berkshire postal history, I came across a GPO Notice dated 22nd March 1909, regarding 'Cycling Duties'. I took a copy as I thought the contents were interesting:

The modern bicycle really just emerged from development over a number of years: The French 'Draisine' of 1816 gave us the steering of the front wheel. In 1839, driving levers and pedals were added by the Scot Kirkpatrick Macmillan, enabling the rider to propel with his feet off the ground. The precursor of the modern 'bike', popular in 1855, was a French, crank-driven, loose-pedalled velocipede. The frame & wheels were made of wood. In England, it was known as the 'boneshaker' due to our cobbled streets. In 1869, the name 'bicycle' was patented, and solid rubber tyres mounted on steel rims were introduced. By 1873, the Starley family of Coventry were producing the 'high wheeler' 'Pennyfarthing'. Modifications over the next 15 years

included ball bearings, pneumatic tyres, welding tubing & spring seats and by 1880, the 'safety' bicycle (so called as wheel size normal-less likely to crash).

In 1880, the GPO actually tried tricycles in Coventry, but the fitness of postmen was in doubt and mail was not easily carried. A Horsham architect came up with the 'centre-cycle', a Pennyfarthing with four small wheels. With the parcel post in 1883, the 'Hen & Chickens' was fitted with an array of shelves.

By 1895, there were 67 'safety' cycle posts recorded for delivery of mail & telegrams. In 1897, the Diamond Jubilee year, free delivery of telegrams was extended to 3 miles. Boy messengers had morning exercises to keep them fit for work! The future of the cycle was assured.

CYCLING DUTIES.

I .am directed by the Postmaster General to inform you that as a result of enquiries made into the subject by Dr. Sinclair, Second Medical Officer, and Dr. D'Arcy Power (on behalf of the Postmen's Federation), he has authorised the following regulations regarding the employment of Postmen on Cycling duties in Town and in Rural Districts. These rules supersede those already issued on the subject; and Circulars to Surveyors, No. 11 of 1903 (first half) and No. 22 of 1907, are hereby cancelled,

miles. In neither ease should the time spent in actual travelling exceed six hours.

TOWN DISTRICT..

(a) Bicycles are not used to any great extent in town districts; and their use in such districts is practically confined to collection and station services. It is in these circumstances not considered necessary to lay down any definite instructions as regards the limit of weight and distance for such cases; but every care should be exercised to avoid requiring the performance of any bicycle services which might conduce to an undue strain or to overwork.

(b) The maximum distance for tricycle carrier work in town districts is 25 miles, and the maximum weight to be carried is 112 lbs.

In all cases assistance should be given, irrespective of weight, if the load is so bulky as to prevent the Postman from controlling his machine properly.

It is usually convenient that bicycles used for Postal purposes (including reserve machines) should be fitted with carriers; and where a carrier seems to be required application should be made to the Controller of Stores for it.

The use of trailers should not be recommended where the roads are rough or hilly, or the conditions are in any

The rate of travelling will depend on the circumstances of each case, and the times fixed should be such as can be kept under normal conditions at a speed not exceeding six miles per hour. Additional time should be allowed when the state of the weather and the road surface are unfavourable. In fixing the time, it should be assumed that the Postman will walk up every hill whose gradient is as much as 1 in 17.

As far as possible cycling duties should be regular and not intermittent, and should not .be performed by several men in rotation. The Postmaster General recognises that there are cases in which the immediate application of this rule would involve extensive revision of duties; but whenever opportunity offers, when revisions are being carried out or at other times, it should be enforced. When cycling duty is thus performed regularly, no " rest periods " are necessary, and the duty should be arranged on the some principles as a foot post; but in cases where regular cycling duty cannot at present he arranged, and the duty is of an arduous nature, the question of allowing short rest periods to enable the Postman to recuperate before resuming duty should be considered. There is no objection to a combination of cycling and walking duties.

The medical examination now imposed upon persons taking up cycling duties will in future be more searching and should be repeated every four years so long as the men are employed on cycling work, and, in the case of a man who has had any serious illness, before he resumes duty. Special forms of medical report will be used in such cases. Supplies of these forms will be issued shortly; and the Postmaster should send one to the Medical Officer on the occasion of each examination. Any complaint of physical unfitness or discomfort from cycling should of course be investigated without delay irrespectively of the periodical examination. Persons now performing cycling duties who have not previously been medically examined in connexion with that work should be sent for examination by the Medical Officer as soon as possible

No fees will be payable to the Medical Officers in respect of these examinations, which will form part of their

official duties covered by the capitation fees.

No man should, as a rule, be placed on a cycling duty before the age of 20 or after the age of 40, unless (in the

latter case) he is already a practised cyclist. Men who have been placed on a cycling duty before the age of 40 may, of course, remain on the duty after reaching that age.


Postmen employed on cycling work should be strongly recommended to wear woollen vests and drawers, and opportunity should, when possible, be afforded to men who get wet to change their clothes.

Men who use machines not provided for their exclusive use should be instructed carefully to adjust the saddle.

I note from the 1909 Notice that


- 1. Minimum age is 20: Maximum 40 unless a practised cyclist.
- 2. Medicals to be given every 4 years.

One has the picture of a gladiatorial postman peddling 26 miles on poor roads, at 6 mph up a hill of 1:18 covered in bags, sweating profusely in his woollen undergarments! The Notice does state that "assistance should be given, irrespective of the weight, if the load is so bulky, as to prevent the controlling of the machine". What help I wonder?!



In Peterborough, cycles (like today) were mainly used for town and local delivery. As the Office had responsibility for outlying districts. contracted horse / cart coach transport widely used. They too, were used to the full. Horses could be given 'sick notes' (see

example) as well as their handlers! A smart Mail gig with 'VR' proudly stamped on the side was used for the mail to Crowland. This is pictured on the left taken from a very poor copy and showing driver Mark Middleton, over fifty years ago, a famous man of the day.




Illustrated on the left is the horse Mail Van which covered the route to Folkingham until 1915.

Peterborough was ahead of the mainstream introduction of motor vehicles. As early as 1906, the Office was using a motor van on the Peterborough to Sleaford route. The contract for constructing the van (E.R. on the side) was won by the Peterborough Motor

Co., with Mr J Rowe at its head. It was a double-cylinder, 10-12 hp, registered to travel at 16 mph but capable of 25 mph in an emergency.

With the advent of WW1, technical advances were rapid and by the 1920s a fleet of the first mass produced vehicles was purchased from Ford. Buying American was



considered unpatriotic in some quarters, so in 1927, Morris was selected and dominated the fleet until after WW2.


Civil wars and international disputes produce local stamps



Postage stamps are an expression and embodiment of national identity. One of the first things that a nation does after it becomes independent is to issue postage stamps. Sometimes independence is disputed by another nation or not recognized by the international community. Stamps issued in such cases are often considered local post stamps because they have little or no validity beyond the area that the government that issued them controls. Local post stamps can be a problem for collectors, because their postal validity is often in question, and they may not be listed in standard stamp catalogues.

Stamps issued by disputed states during the 19th century include the Confederate 5\$ Jefferson Davis stamp (Scott 1) and the Spanish Cellist 50-centimo King Carlos VII stamp (X6) shown in Figure 1. From

the early 20th century. Russian Civil War (1918- 21) issues abound. A South Russia 20-kopek Yermak, Cossack Leader stamp (Scott 10)1s shown in Figure 2. Later in the 20th century, the breakup of colonial empires in Africa led to civil wars and power struggles. In July 1960, Katanga province seceded from Congo, resulting in a civil war that lasted until September 1963, when the last Katangan troops surrendered. On Nov. 11, 1965, the white minority government of the British colony of Southern Rhodesia issued a unilateral declaration of independence as the nation of Rhodesia. As a result of international pressure and embargoes, Britain eventually regained control of the colony in December 1979. On May 30, 1967, Biafra seceded from Nigeria. A bloody civil war ensued and the Biafrans did not surrender until Jan. 15, 1970. The Scott Standard Postage Stamp Catalogue lists the stamps of Katanga and Rhodesia, but not those of Biafra. A Rhodesian 2144 Head Injury and Safety Helmet stamp (Scott 358) is shown in Figure 3.



In 1978, the East African nation of Somalia collapsed into anarchy. No central authority has been able to assert control over the country ever since. On May 18, 1991, the northern part of Somalia, which was formerly the British Somaliland Protectorate, declared independence as the Republic of Somaliland. Although lacking international recognition, Somaliland has the most effective and stable government in any part of Somalia. Colorful topical stamps inscribed 'Republic of Somaliland" have been issued. Whether a local post system actually uses them to deliver mail there is open to question.

Stamps inscribed "Sahara Occ. RA.S.D." (Republica Arabe Saharaui Democratic) have been issued for Western Sahara. Spain withdrew from its colony Western Sahara in 1975. By secret agreement, Morocco was to annex the northern two- thirds of the country, while Mauritania was to annex the southern third. As the Spanish withdrew, most of the native population, called Saharawis, fled into refugee camps in Algeria. The Polisario Front operates as a government in exile in the Saharawi refugee camps. Western Sahara's local stamps are produced primarily for sale to stamp collectors.

Nagorno-Karabakh (Mountainous Karabakh) is a region inhabited by Armenians that was assigned by the Soviet Union to Azerbaijan. Warfare over the region broke out with the collapse of the Soviet Union in December 1991. Nagorno-Karabakh, supported by Armenia, won the war, and a cease-fire was signed on May 12, 1994. Although not internationally recognized, the Armenians have been in de facto control ever since. Nagorno-Karabakh local stamps are listed in the Stanley Gibbons Stamp Catalogue, Part 10, Russia. A 200-dram We Are Mountains stamp (Stanley Gibbons 11) is shown in Figure 5.

The Russian Federation supports separatist movements in the former Soviet republics of Moldova and Georgia. The Transnistrian Moldavian Republic (Pridnestrovskaia Moidavskaia Respublica or PMR) lies along the eastern bank of the Dniester River in Moldova. The population of Transnistria is a mix of Russian, Ukrainian and Moldovan. Shortly after Moldovan independence in 1991, Russian nationalists seized control of Transnistria and proclaimed independence. A Russian army occupies Transnistria, which exists with tacit Russian support. On Sept. 19, 2006, Transnistrians voted in a referendum to seek union with Russia. Transnistrian Foreign Minister Valery Litskai announced through Russia's Interfax news agency, "Transnistria's integration into Russia will proceed in several phases, and it may take five to seven years." A Transnistrian 15-ruble Equestrian Statue overprint and surcharge on an old




Figure 6.A Transnistrian 15-ruble Equestrian Statue overprint and surcharge on a Soviet stamp.

Soviet stamp is shown in Figure 6, Western visitors have confirmed that Transnistria operates a postal service within its borders using its local post stamps. Mail destined for foreign countries is franked with Russian stamps.

As Georgia left the Soviet Union, Abkhazia, an autonomous region within Georgia, declared its independence. War, which broke out in August 1992, ended in victory for the Abkhazians with Russian support in 1994. In August 2008, fighting broke out again, this time with direct Russian military intervention in both Abkhazia and South Ossetia, another breakaway region of Georgia. An Abkhazia) 5-ruble Map with Flag overprint and surcharge on an old Soviet stamp is shown in Figure 7, Only Russia and Nicaragua recognize Abkhazia's independence. Linns Stamp News 30.03.2009



SEC files against Escala, Manning, Crawford; Escala settles

In BS 60 on pages 19 - 21, I printed two articles on the financial scam unfolding in Spain, Jordi Quintana had brought these activities to my notice. This follow up information came in "Linn's Stamp News"

The United States Securities and Exchange Commission filed a disclosure and accounting fraud case March 23 against Escala Group Inc., its founder and former chief executive Gregory Manning, and its former chief financial officer Larry Lee Crawford, alleging fraudulent related party transactions between Escala and its parent company, Afinsa Bienes Tangibles SA.

Simultaneous with the filing of the complaint, Escala Group announced it had reached a settlement with the SEC resolving the charges filed. Manning and Crawford are not part of the proposed settlement.

Escala is a network of companies in the collectibles market specializing in stamps and other objects. Afinsa was a privately held Spanish company that sold investments in portfolios of stamps in Europe.

On May 8, 2006, Spanish authorities raided Afinsa and Forum Filatelico, two of Spain's biggest stamp companies, and shut them down amid allegations that the investment plan operated as a pyramid scheme. The Spanish federal investigation is ongoing.

According to a March 23 Escala report: "Under the terms of the Settlement, which has been submitted for court approval, the Company consented, without admitting or denying the allegations made in the SEC's complaint, to a permanent injunction against any future violations of certain provisions of the federal securities laws. No fines, civil penalties or monetary sanctions were assessed against the Company. This settlement concludes the SEC's investigation of this matter with respect to the Company.

According to an SEC news release, the filed complaint alleges "a fraudulent business scheme based upon the secret and dramatic manipulation of collectible stamp values, in which Escala, Manning, and Crawford violated the anti-fraud and reporting provisions of the federal securities laws by: failing to disclose the related party status of Barrett & Worthen, Inc., resulting in control of the Brookman Catalogue, and failing to disclose the revenues obtained by virtue of Afinsa and Manning's control of the prices in the Brookman Catalogue; falsely representing that Escala sold Afinsa several large stamp archives at prices determined by reference to independent stamp catalogues and appraisals when in fact Manning set the catalogue prices and influenced and edited the appraisals; and falsely reporting a payment for business combination-related expenses as the 'sale' of certain antiques.

The complaint alleges that Escala and Manning also violated the anti-fraud provisions by selling back to Afinsa in a round-trip transaction inventory acquired from Afinsa in direct contravention of Escala's public promise not to do so."

In its 42-page complaint filed in the United States District Court, Southern District of New York, the SEC specifically takes note of Manning's purchase of the United Nations archive of die proofs and other philatelic material in June 2003. Asked to comment on the case, Jeffrey C. Hoffman, counsel for Manning, told *Linn's Stamp News*: "We're contesting the allegations. It is our strong position that there was no improper valuation of any of the stamps or any other materials involved, and that the same method used by Greg over the years, which has created the reputation that he's had, is the same method that has been used with this material. The valuations that were described concerning the Broom man catalog have not resulted in one complaint to the Brookman catalog by any of its users, to our knowledge, or that in anyone's view that the valuations in any way, shape or form were incorrect."

The SEC complaint seeks "permanent injunctions against future violations, disgorgement of ill-gotten gains, prejudgment interest, civil penalties, and officer and director bars." I



Chile hosts first philatelic exhibition on Antarctic continent

The Chilean Philatelic Society and the Chilean air force organized the first philatelic exhibition on the Antarctic continent, Expoantartica Chile 2009, to commemorate the 50th anniversary of the signing of the Antarctic Treaty.

The exhibition took place Jan. 5-15 in the gymnasium of Las Estrellas village at Chile's Presidente Eduardo Frei Montalva Antarctic base. The village inhabited permanently by Chilean air force personnel in service at the base and their families, is located on Fildes Bay of King George Island, part of the South Shetland archipelago.

The air force flew all the metallic structures and frames necessary for the exhibits to be mounted from Chile's capital, Santiago, to the base, with a stopover in Punta Arenas on the north border of the Magellan Strait.

Expoantartica Chile 2009 was a great success. More than 100 people visited the exhibition.

The most notable visitor was Prince Albert II of Monaco. He was accompanied by several journalists, who, in relaying information about the prince's activities, also reported on the exhibition.

The prince was well informed about the hobby, as his father, the late Prince Rainier, was a stamp collector.

Other visitors included residents of the village, crew members from various Antarctic bases, passengers of two cruise ships, and tourists who arrived by charter plane.

In addition, a group of 18 high school students invited by the Chilean Antarctic Institute for a short period of training visited the show.

The competitive class of the exhibition was limited to thematic exhibits related to the Antarctic continent. All exhibitors had to be associated with a Chilean philatelic organisation. Thirteen exhibitors were residents of Chile. The other three were from Argentina, Germany and Portugal.

The exhibition organizers had invited the 12 signatory countries of the Antarctic Treaty to participate in a noncompetitive international class. Five of them accepted the challenge, namely: Argentina, Australia, Belgium, Chile and New Zealand.

The other signatory countries were France, Japan, Norway, South Africa, the United Kingdom, the United States and the Soviet Union.

Two cacheted covers were available, one decorated with an illustration of penguins and postage stamps and the other with a map of the Antarctic. The envelopes were in great demand during the exhibition. In addition to the Antarctic base post office's postmark recording the place and date, four other special postmarks were used to commemorate Expoantartica Chile 2009 and the 54th anniversary of the treaty. * Reusing stamps

The Royal Mail's (the British Post Office) attempt, as reported in the Nov. 24, 2008, and Feb. 16 issues of Linn 's, to thwart the reuse of used but un-canceled stamps by issuing stamps that can't be soaked off will not deter the efforts of those who are determined to reuse such stamps.

The security features will prevent the stamps from being soaked, but I can think of at least two ways they can be circumvented. One is to cut closely around the stamp, leaving it on piece, and glue the piece on to a new envelope. Another is to open the envelope carefully, using steam if needed, and reuse the entire envelope with a new address label pasted over the old one. This may not be ethical, but from a legal standpoint I think that any stamp that has not been canceled is still technically legal tender.

Of course, the biggest loser in all of this is the collector of used stamps. Michael Little Belleville, N.J.

Collectors as conservators

Over the past few months Readers' Opinions letters have debated the rules for collecting postal stationery.

One position is that there are no rules, and that individual collectors can collect however they wish, cutting out whatever part of the stationery they want.

The other position, accepted by an informal consensus of current collectors, is that these items should only be collected as en-tires.

Obviously no rules are imposed by some central collecting authority and individual collectors can collect postal stationery as entires or as cut squares. However, the debate has, so far, largely passed over an important point.

We collectors are not just owners oldie items we collect. We are their guardians for future generations of collectors. As such, we should avoid the destruction of philatelic items just to make these items fit better into our collections.

The history of philately has far too many examples of collectors who destroyed items just to shoehorn them Into a specific collecting format.

Two cases come to mind.

In the past, pre-cancel collectors soaked pre-canceled stamps off cover, destroying untold numbers of postal history covers. Thus, pre- canceled special delivery stamps are pretty common, but there are fewer than a dozen covers showing pre-canceled special delivery stamps properly used.

For years, postmark collectors mutilated covers and cards by cutting a 4-inch by 2-inch piece from the upper right corner to keep just the postmarks. We will never know how much priceless postal history material was thus destroyed.

Every collector should realize that he has a responsibility to preserve the material he collects for future generations. Mutilating a card or cover by cutting it up to add just a portion to a collection is akin to destroying an old painting by cutting out an angel from the artwork for a collection of angels on canvas.

Postal court battles waged in Germany and Great Britain

The commercial use of the word "Post has been the subject of recent court battles in Germany. In 2003, Deutsche Post registered the word "Post with the German Federal Patent and Trademark Office. In submitting the registration, Deutsche Post stated that 84.6 percent of consumers in Germany associated 'Post" with Deutsche Post.

Competitors challenged the trademark in 2007, and initially won the challenge in the German Federal Patent Court. However, upon appeal, the ruling was overturned by the German Federal Court of justice in October 2008.

This doesn't necessarily mean that a private delivery firm in Germany will have to remove "Post" if it is part of its name.

An Oct. 24, 2008, press release from Deutsche Post says that competitors cannot combine the word "Post" with other items associated with Deutsche Post, including the color yellow and a post horn symbol. The German computer- vended personalized post shown includes the name "Deutsche Post" and the post office's post horn logo. The ladybug shown on the left is one of the 200 designs that customers can select from to create personalized postage, which is printed on the customer's personal computer.

A recent court case in Great Britain centered around the amount compensated by Royal for items lost in the mail.

The Nov 6th, 2008, issue of the Antiques Trade Gazette reported on the case of Bruce Goulborn, a dealer in coins, banknotes and postcards, against Royal Mail. Goulborn had shipped 21 postcards to four clients,

All the cards were lost in the mail. Royal Mail only reimbursed Goulborn the amount he paid for the cards, not the amount he sold them for.



Royal Mail has no intention of changing its policy.


A Royal Mail spokesman told the Antiques Trade Gazette, "Basically we don't pay someone's profit."


